I hereby agree and consent to serve the Real Junta de Fomento of the Island of Cuba, on their Rail Road, in the capacity of Machinist, either, on the road in running an engine, or in the shop as a mechanic, exerting myself to advance & protect their interests as far as in me lies; yielding prompt and cheerful obedience to all orders issued by my superiors and conducting myself in an orderly and respectful manner towards them.

I shall expect such wages for my services as my services may warrant and such as those receive upon said Rail Road of the same class with myself.

The time for the commencement of my pay, to be computed from the date of this agreement & my passage money in the steerage refunded to me or paid for me by the Real Junta &c, and if a Cabin passage the excess to be paid on my account & to be subsequently deducted from my wages.
